- d) **Uploading the Undertaking & Anti Ragging Form:** Student require to print the Undertaking and Anti Ragging Form attached with the notice and fill the form and sign the document and upload it on the document tab.
- e) **Fee Link:** Student shall receive the Payment Link, once the college approves the Application form the student should check their login for fee link activation and make the payment through Net banking or Debit/ credit Card (except RUPAY card). The link shall be active till the last date of admission.
