#### **SUMMER EXAMS – MAY 2021**

Dear Students,

In pursuance of the lead colleges meeting held for discussing the conduct and form of the forthcoming examination in the month of May 2021, the following has been agreed upon and the students are hereby notified of the below stated:

- The backlog exams are to be conducted for Semester II, III, V (3 years) and Semester II, III, V, VII, IX (5 years) from May 02<sup>nd</sup>, 2021.
- The regular examination to be conducted for Semester IV & VI (3 years) and Semester IV, VI (with backlog of Sem II – 3 years), VIII & X (5 years) from May 17, 2020.
- The **Question paper pattern** for the exam:
  - 20 (Compulsory) Multiple Choice Questions for a duration of 30 minutes for 30 Marks;
  - 10 (Compulsory) Descriptive Questions for a duration of 60 minutes for 30 Marks
  - The descriptive questions will be expected to be answered online on the exam software (typed format). Each question will be allotted 3 Marks;
  - Medium: English/Marathi
- The exam shall be of the entire syllabus as prescribed by the University of Mumbai.
- The college will confirm the username and password for the forthcoming examination to be conducted through online mode with you shortly.
- The exams shall be held through **online mode** and the link for the same will be shared with the students accordingly.
- Students must make requisite arrangements to appear for the online examination. (i.e. Smartphone/ Laptop/ Desktop/ any other gadget/ Internet Connectivity). We
