


About Malad Kandivli Education Society

ADMISSION GUIDELINES

Any candidate who provides incorrect or misleading information while filling, submitting or uploading details in the CET registration form or during College admission will be held solely responsible for the consequences. If such discrepancies are found during the verification process by the college or CET/ARA or any concern authorities, the candidate will face penalties. The college will not be held accountable and no refund of fees will be granted. The admission will be forfeited immediately.

Fees: The Academic fees is as notified by Fees Regulating Authority or competent authority from time to time.

Age of Admission: There is no upper age limit for admission to Law program till now, in view of the case pending in Hon. Supreme Court of India in WP(Civil): No. 1023/2016 and the order passed by the Hon. High Court, Bombay in WP 3235/2016.

GUIDELINES FOR FIRST YEAR ADMISSION

BACHELOR OF LAWS (LL.B.)

ELIGIBILITY FOR ADMISSION

A candidate for being eligible for admission to First Year of 3 Years LL.B Degree Course must have Passed/completed Degree Examination in any Faculty of a recognized University or equivalent qualifica with minimum 45% of marks in aggregate **marks** in qualifying examination (that is 45% marks for all parts of degree examination taken together).

Aggregate Marks means the Marks for all the parts of degree examination taken together. The qualifying Percentage shall be calculated on the basis of Aggregate marks irrespective of the Percentage declared by the University. The percentage of marks shall be calculated by rounding off to two places after decimal. This round off will be applicable to the Percentage above the Minimum Percentage of Marks required for qualifying examination. Eg. 44.99% cannot be round of to 45% in case of Open Category.

Incase the candidates are awarded grade/s/, CGPA instead of Marks any part of the marksheets. The conversion of the Grades/CGPA to percentage of marks would be based on the formula duly certified by the Principal of the college/University/Institution from where the candidate has obtained the degree.

For admission to the First year of three years LL.B. Course, the Common Entrance Examination conducted by CET cell Maharashtra State is mandatory requirement.

The candidates should fulfill all the requirements specified in the Information Brochure for Centralized Admission Process (CAP) 2025-2026. Candidates are advised to read the CAP & CET Information Brochure carefully. Minority Students: The Maharashtra domicile candidates belonging to Gujurati Linguistic Minority community from Within the state of Maharashtra are eligible under this category. Domicile certificate for such candidate is mandatory to claim seat under Minority quota.

BACHELOR OF ARTS & BACHELOR OF LAWS (B.A. LL.B.)

ELIGIBILTY FOR ADMISSION

A candidate for being eligible for admission to the First Semester of 5 years B.L.S / LL.B. Degree Course must have Passed/completed H.S.C. examination i.e (10+2 pattern) or equivalent qualifications with minimum 45% of marks at the qualifying examination.

ADMISSION PROCEDURE

For admission to the First year of five years B.L.S / LL.B. Course, the Common Entrance Examination conducted by CET cell Maharashtra State is mandatory requirement.

The candidates should fulfill all the requirements specified in the Information Brochure for Centralized Admission Process (CAP) 2025-2026. Candidates are advised to read the CAP Information Brochure carefully. ELIGIBILITY FOR ADMISSION

Candidates who have passed LL.B. or those who have appeared for the Final Semester Examinations of 3 or 5 year LL.B. Programme from the University of Mumbai or any other recognized University are eligible to apply for online LL.M. Common Entrance

ADMISSION PROCEDURE

Admission to LL.M two year programme shall be made in accordance with the merit list of the LL.M. entrance examination every year. Candidates are required to secure at least Minimum Qualifying Marks in the LL.M. Entrance Examination i.e 40% Marks - For General Category and 30% Marks - For Reserved Category

- 1) College Admission Form
- 2) LL. M. Entrance Score card
- 3) Law Graduation Marksheets
- 4) University Enrolment Form

ADMISSION GUIDELINES FOR SUBSEQUENT YEAR

For each subsequent year, students shall fill in a fresh admission form of College and University Enrolment Form and pay the necessary fees on or before the date fixed.

Candidates for being eligible for admission to the Second / third Year of 3-year- LL.B. course or Second / Third / Fourth/ Fifth Year of 5 Year B.A. LL.B. Course must have either passed in the examination of the previous Semester or must have got exemption in at least six papers (excluding practical training paper) of the first and second semesters and follow the guidelines of University of Mumbai

For Admission in Second Year in LL.M. shall be as per University norms, students shall fill in a fresh admission form of College and University Enrolment Form and pay the necessary fees on or before the date fixed. Thereafter Late fee may be charged at the discretion of Principal & Management.

CANCELLATION OF ADMISSION AND FEE DEDUCTION

Candidate shall apply offline handwritten letter for cancellation along with the fee receipt mentioning the reason for cancellation of their admission to the course. The refund of fees will be as per rules prescribed by the competent authority or the University of Mumbai. No refund once the session commenced.

The institution shall cancel the admission immediately and generate online acknowledgement of cancellation of admission through institution login and issue a signed copy to the candidate.

The refund of fees before cut-off date of admission schedule declared by the Competent Authority shall be made within weeks' time after deducting the processing charges of Rs.1000.

If the admission is cancelled after the cut-off date of admission declared by the Competent Authority, there shall be no refund except the Security Deposit and Caution Money Deposit.

NOTE: The students are advised to preserve their fee receipt carefully.

Refund of deposits / admission cancellation fees will be made only by a cheque on submission of the original fee receipt.

The Lecture timing for LLB. (3 years) are held in the morning from 8.00 am. to 1.30 pm. Practical training tutorials, viva and case study classes will be held after that.

The Lecture timing for B.A. LL.B. (5 Years) are held in the morning from 10.30 am to 4.00pm

The lecture timeing for LL.M. (2 Years) are held in the morning from 8.00 am to 1.30 pm

CURRICULUM AS PER THE UNIVERSITY OF MUMBAI

As per University of Mumbai Undergraduate Law programmes (LL.B. -3 Years) & B.A LL.B. (5Years) and LL.M. (2 years) are under the Faculty of Inter - Disciplinary Studies.

B.A. LL.B (5 Years) & LL.B (3 Years)

The Curriculum & Examination Pattern will be as per the University Of Mumbai. In continuation with Circular No. UG/19 of 2019-20 dated 20th May, 2019 relating to the implementation of CBCS system for the Three Years LL.B (Sem I to Sem VI) and Five Years B.A/ LL.B. (Sem I to Sem X) programmes. CBCS 60:40 introduced in 2019-20, the revised Circular no. AAMS/UGS/ICC/2022-23/168 dated 17th November 2022 has been implemented with CBCS 75:25 pattern. The Curriculum & allotment of marks will as per the University of Mumbai. For details of the same, the students are advised to refer to the circular No. AAMS_UGS/ICC/22023-24/18 dated 26th June 2023 available on the University's Website www.mu.ac.in and College Website

Standard of Passing The Examinations

The performance of the learners shall be evaluated into two components. The learner's performance shall be evaluated by Internal Assessment with 25% marks as the first component and by conducting the Semester End Examinations with 75% marks as the second component. The learners to pass a course shall have to obtain a minimum of 40% marks in aggregate for each course where the course consists of Internal Assessment and Semester End Examination. The learners shall obtain minimum of 40% marks (i.e. 10 out of 25) in the Internal Assessment and 40% marks in Semester End Examination (i.e. 30 Out of 75) separately, to pass the course and minimum of Grade E, wherever applicable, to pass a particular semester. A learner will be said to have passed the course if the learner passes the Internal Assessment and Semester End Examination together.

LL.M.

The Curriculum & Examination Pattern for LL.M. is as per University of Mumbai. The LL.M Course follows the Semester System and is of duration of 2 years (Four Semesters). The academic year, which consists of two terms, begins in July and ends in May. The LL.M. course is available in six specializations. (Groups), the college provides the below mentioned three Specialization:

- Group II Business Law
- Group III Law of Intellectual Property and Information Technology
- Group V Criminal Law and Criminal Administration

Standard of Passing

To pass LL.M. examination the candidate must obtain 45% marks in each paper and 50% aggregate in each semester. Those successful candidates who obtain 55% to 59% Second Class 60% and above First Class. The Class will be awarded on the basis of the total performance of the student in all the four Semesters. However, a student claiming exemption will be entitled to pass class only. The dissertation shall be evaluated by a team of teachers of the concerned group and External Expert nominated by College Committee. The Marks shall be awarded after joint consultation by both the evaluators. A student may be exempted at his choice from appearing in any of the papers, if he has secured at least 50% of the total marks in that paper. Students failing in Dissertation/Project and Viva Examination in the Fourth Semester shall again undergo for the Dissertation and Viva as the case may be. The final approved dissertation shall be submitted on Cdrom in addition to two hard copies. The same procedure shall apply to failure in Choice-based credits. All research projects, dissertations & other research assignments are required to be in accordance with the circular of the University of Mumbai dated 15th June 2018, no. Exam./Thesis/Uni/VCD/947 of 2018 and University Grants Commission (Promotion of Academic Integrity & Prevention of Plagiarism in Higher Educational Institutions) Regulation.

SEMESTER SYSTEM

The Law degree will not be conferred upon a candidate unless the candidate has passed in, or cleared all the papers prescribed for each Semester examination in accordance with the provisions relating to each Semester examination. The performance of the students will be evaluated by the Examination to be conducted at the end of the every Semester and also by his/her performance in the Practical Training and DPC Papers as per the guidelines issued from time to time by the Bar Council of India & University of Mumbai.

Medium of Instruction: English

Teaching Staff: The Teaching staffs of the college consists of full time teachers and visiting teachers who are either recognized post graduate teachers for law college or persons of eminence in the filed of their specialization.

Teaching methods: classroom lectures, interactive sessions & discussions, case studies, powerpoint presentation & documentaries, seminar & workshops, mooting (debating points of law before a judge), guest lectures, practical training, project work field visits etc.

EXAMINATION GUIDELINES TERM GRANT AND EXAMINATION

There will be an examination at the end of each semester. The examinations at the end of the semester I to VIII in B.A.LL.B. and Semester I to IV will be held by the college on behalf of the university of Mumbai according to the University of Mumbai rules.

To keep a term at a college or recognized institution, an undergraduate must complete to the satisfaction of the Principal, the requisite attendance for each term of the every academic year as per ordinance 0.6086

In order to be eligible for admission to the Third semester, a candidate must have either passed in the First and second semester or should have received an exemption in at least four/six papers of the first and second semesters. This is similarly applicable for the remainder of the semesters of Three years and Five year law program.

ATTENDANCE NORMS

The term's 'working days' means that the days on which the lectures are delivered. As per the University Ordinances 6086 (Circular No. UG/01 of 2014 dated 5th May 2014), Every bonafide learner shall ordinarily be allowed to keep terms for the given semester in a course of his/ her enrollment only if he/she fulfill at least 75% of the attendance per semester. Attendance is taken as an average of the total numbers of lectures, practical's, tutorials etc. conducted by the college. A student whose attendance in any semester is not satisfactory (as per Rules of University of Mumbai ordinance 0.6086) will be subject to disciplinary action. The decision was taken by the principal shall be final. The college is monitoring the attendance as per the University Ordinance 6086. The Attendance Committee has been formed to maintain the attendance record of all the students admitted in said academic year

Leave of Absence: In case students are not able to attend lectures and/or tutorials for a period exceeding a week in a term, they should give intimation to the Principal of the College and take prior permission for such absence.

Absence on medical or other grounds: Absence on medical or other grounds, which is given to the satisfaction of the Principal may be considered a satisfactory reason for absence from lectures tutorials. At the time of granting the terms to a student his/her classwork and other academy inputs would be considered to be of paramount importance. Hence, a student may not be granted his/her terms even if he/she explains his/her absence on medical or other grounds.

UNFAIR MEANS AT EXAMINATIONS

A students who are found copying or using any unfair means as per University of mumbai Ordinance 0.5050 during the Examination will be punished accordingly. The Unfair Means committee is set up to inquire about the alleged unfair means and practices by the students during any examinations (Internal/External/ Practical) and will follow the procedures and guidelines issued by University of Mumbai under Ordinance 5050.

STUDENT SUPPORT:

Identity Card:

- 1) One time Identity Card shall be issued at the time of admission and is valid for the said Academic year. Students should have their identity cards while in the college premises and produce the same whenever required by any member of the college staff.
- 2) Every student must display his/her ID card to the security personnel at the gate, failing which he or she may not be allowed to enter the college premises.
- **3)** In case of loss of the Identity card, a student should inform the admin office of the college. A duplicate Identity card shall be issued on payment of Rs. 100/- along with the receipt of Police complaint from concerned Police station and student written application to the admin office. The duplicate Id card shall be issued within 5 working days.

Railway Concession:

Student can avail concessional fares for local trains from Malad station to the nearest station to the place of their residence in Mumbai. Student has to fill the railway concession form available on the website. Student are requested to enter their local address as mentioned in the admission form to facilitate the issue of railway concession. Incase of change in address, the requires to inform the college office with supporting prior to the application for railway concession. The same shall be issued within 3 working days. The students are required to collect the same as per mentioned time schedule.

Transcripts:

Students, who wish to pursue further studies in any other universities abroad should apply well in advance. The student should apply for transcript well in advance. The Application form for Trasncript is available on the website and should be submitted with clear and visible xerox copies of the mark sheets. After verification of original mark sheets with the copies, The college shall issue the transcript within 15 working days from the date of Application. The amount payable for Transcripts is Rs. 1000/- for 5 set of Copies. Every additional copy, if required should be requested through an application and shall be issued at a cost of Rs. 200/- per copy. Additional copy shall be issued within 7 working days. The students are required to collect the same as per mentioned time schedule.

Bonafide Certificate/Letter of Recommendation/No Objection Certificates or any other certificates:

Students are required to apply for the same to the college office during college hours. The charge for such certificates shall be Rs. 100/- and shall be issued within 7 working days from the application date. The students are required to collect the same as per mentioned time schedule.

Transfer Certificate:

The students are required to apply for the same along with the application of new admitted college. The transfer Certificate shall be issued with the fee of Rs. 100/- and within 7 working days. The Transfer certification shall not be granted except for the reasons, which appear to be sufficient and with written permission of the Principal of the College.

The student portal is a cloud based software solution that streamlines student's data through systematic digitalization. The system's all-in-one platform offers data security of student's information, admission & enrolment management, mobile Application, Examination Management etc. under one roof.

NOTICE

In pursuance to the Judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009, the University Grants Commission has framed UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009'which have been notified on 4th July, 2009 in the Gazette of India. These regulations are mandatory for all Universities/Institutions. The UGC has made it mandatory for all students / parents to submit anti ragging related affidavits to the institutions at the time of admission. Now it is brought to the notice of all Universities, Institutions, Students and Parents that these affidavits can be downloaded from the website of UGS and or other related websites.

Further as per revised procedure for Anti Ragging Mechanism vide circular of University Grants Commission no. UGC: D.O. No, F.3-2/2021 (ARC) dated 27-10-2021 & University of Mumbai No. SW/17/of 2021, students are requested to adhere to the guidelines issued by UGC for Anti Ragging Mechanism that are as follows:

1. It is mandatory for each student to submit his / her details on the web sites www.antiragging.in & www.amanmovement .org and read and confirm that he/she & his/her parents/ guardians have read and understood the regulations on curbing the menace of ragging. 2 The student will receive an Email with his/ her registration number and a web link. The student will forward the said link to the college. Please note the Anti-Ragging Helpline no. is 1800 180 5522.

Students found indulging in ragging or any activity resembling ragging will be strictly punished and may also be expelled from the college and a First Information report lodged with the law enforcement agencies against them. Moreover the cause of expulsion due to indulgence in ragging will be cited in the college leaving certificate of such students

Prohibtion of sale of Cigarettes or Tabacco Products

The Hi-tech computer Lab of the college has many latest computer softwares and internet access.


MOOT COURT
