## BACHELOR OF LAW (LL.B)

*Ps:- Any candidate filling in or submitting or uploading any wrong / incorrect information during online registration of CET form or in college admission form for admission purpose, and any time the same is inspected during the verification procedure by college or CET / ARA representative will be penalized for submitting / providing wilfully wrong information. The candidate himself will be responsible for the consequences and the college shall not be responsible for the same. The fees shall be forfeited and no refund can be claimed by the candidate thereafter.*

### ELIGIBILITY FOR ADMISSION

A candidate for being eligible for admission to the First Year of 3 years LL.B. Degree Course must have passed/completed Degree Examination in any Faculty of a recognized University or equivalent qualification with minimum 45% of marks in aggregate in qualifying examination ( that is 45% marks for all parts of degree examination taken together).

### ADMISSION PROCEDURE

For admission to the First year of three years LL.B. Course, the Common Entrance Examination conducted by CET cell Maharashtra State is mandatory requirement.

The candidates should fulfill all the requirements specified in the Information Brochure for Centralized Admission Process (CAP) 2022-2023. Candidates are advised to read the CAP & CET Information Brochure carefully. ## **CANCELLATION OF ADMISSION AND FEE DEDUCTION**

The candidates who have taken admission in first year for the current academic year may request for refund of fees after applying in writing reason for cancellation of their admission to the course. The refund of fees will be as per rules prescribed by the competent authority or the University of Mumbai.

## **WORKING HOURS**

The working hours for the college Administration office is from 9.00 am. to 4.00 pm.

The Lecture timing for LLB. (3years) are held in the morning from 8.00 am. to 1.30 pm. Practical training, tutorials, viva and case study classes will be held after that.

The lecture timing for B.LS/LLB. (5years) are held in the morning from 8.00 am to 1:30 pm

## CURRICULUM AS PER THE UNIVERSITY OF MUMBAI

As per University of Mumbai Undergraduate Law programmes (LL.B. -3 Years) & B.L.S /LL.B. (5Years) are under the Faculty of Inter - Disciplinary Studies. The Programmes carry following values credits:

- ♦ Undergraduates 3 Years LL.B. Programme is 20 credits each in semester I to VI i.e total 120 credits for complete program
- ♦ Undergraduates 5 Years B.L.S / LL.B. Programme is 15 credits each in semester I to IV (4semesters) and 20 credits each in semester V to X (6 Semester) i.e total 180 credits for complete program.

The performance of the student shall be evaluated into two components: Internal Assessment with 40 % marks in the first component and conducting the semester End Examination with 60% marks in second component. (Reference: University of Mumbai Circular No. UG/107 of 2018-2019 dated 24/08/2018)

For the Semester I to IV of LL.B. 3 (years) program and Semester I to VIII of B.L.S/ LL.B. 5 (years) program shall be processed by the college on behalf of the university of Mumbai. For the Semester V to VI of LL.B. 3 (years) program and Semester V to X of B.L.S/ LL.B. 5 (years) program , Internal Assessment shall be processed by the college on behalf of the university of Mumbai and Semester End Examination shall be conducted by University of Mumbai. The results shall be awarded accordingly.

#### ◆ SEMESTER SYSTEM

The Law degree will not be conferred upon a candidate unless the candidate has passed in, or cleared all the papers prescribed for each Semester examination in accordance with the provisions relating to each Semester examination. The performance of the students will be evaluated by the Examination to be conducted at the end of the every Semester and also by his/her performance in the Practical Training Papers DPC as per the guidelines issued from time to time by the Bar Council of India & University of Mumbai.

#### ◆ METHODS OF TEACHING AND LEARNING

Teaching methods include classroom lectures, interactive sessions & discussions, case studies, powerpoint presentation & documentaries, seminar & workshops, mootng (debating points of law before a judge), guest lectures, practical training, project work field visits etc.

#### ◆ TUTORIALS

Tutorials and practical are a means to supplement lectures in certain subjects. Attendance in these tutorials is compulsory.

#### ◆ STANDARD FOR PASSING THE LAW EXAMINATION

The students are require to pass a course shall have to obtain a minimum of 40% marks in aggregate of Internal assessment & semester End Examination taken together. To Pass a Particular semester students shall have to obtain minimum of 30 % marks in Internal Assessment (i.e 12 out of 40) and 30 % marks in Semester End Examination (i.e 18 out of 60) Separately and minimum of grade E in each course



## ◆ Allowed to Keep Terms (ATKT)

a) Students shall be allowed to keep term for Semester 2, 4 and 6 of the 3 years LL.B. programme and Semesters 2, 4, 6, 8 and 10 of the 5 years B.L.S.,LL.B. programme irrespective of number of heads of failure in the Semester 1, 3 and 5 of the three years LL.B. programme and Semesters 1, 3, 5, 7 and 9 of the five years B.L.S.,LL.B. programmes respectively.

b) A student shall be allowed to keep terms of both the semesters of the higher semesters of the law programmes if he has not failed in more than 2 subjects/courses out of the subjects/courses of both the semesters of the respective law programmes taken together of the immediately preceding year and has passed in all the subjects/courses of all the semesters of the respective law programmes preceding to the immediately preceding semesters of the year he is seeking admission. (e.g. students seeking admission to the third year (semesters V and VI) of either of the LL.B. programmes shall have to pass in all the courses of the semesters I and II and shall also have pass in any six courses of semesters III and IV taken together)

c) The result of Semester VI of the three years LL.B. program or of Semester X of the five years B.L.S/ LL.B. program shall be kept in abeyance until the student passes in each and all of the subjects/courses of all the courses in all the semesters of the respective law program.

## ◆ ATTENDANCE REQUIREMENT / UNFAIR MEANS AT EXAMINATION

A student whose attendance in both the terms is not satisfactory (as per Rules of University of Mumbai ordinance 0.6086) may not be allowed to appear for the examination Besides, a student who is found irregular for both semesters will be subject to disciplinary action. The decision was taken by The principal shall be final.

**Leave of Absence:** In case students are not able to attend lectures and/or tutorials for a period exceeding a week in a term, they should give intimation to the Principal of the College and take prior permission for such absence.

**Absence on medical or other grounds:** Absence on medical or other grounds, which is given to the satisfaction of the Principal may be considered a satisfactory reason for absence from lectures tutorials. At the time of granting the terms to a student his/her classwork and other academy inputs would be considered to be of paramount importance. Hence, a student may not be granted his/her terms even if he/she explains his/her absence on medical or other grounds. Absence should be with prior permission in case it is due to unforeseen circumstances an application duly supported by other satisfactory evidence in the case of other reasons must reach the Principal within a week of such occasion of absence.

## ◆ UNFAIR MEANS AT EXAMINATIONS

A students who are found copying or using any unfair means during a test examination will be instantly expelled from the examination hall and be also subject to disciplinary action. The decision taken by the Examination Committee in this matter will be final

## CLASSROOM

There are adequate numbers of classrooms. All Classrooms are air conditioned and designed as per high standards. The teaching is imparted with the help of LCD projectors and other sophisticated teaching aid.

## LIBRARY

A well stocked library, with automated system, is one of the attractions of M.K.E.S. College of the Law. It subscribes to leading international and national journals in the domain of law. The library also subscribes to & Law Finder (Legal Database). The training sessions on how to use library resources and the databases are conducted on regular basis. The Library is open from 09:00am to 5:00pm.

## GYMKHANA

## MOOT COURT

The Moot Court Hall or Room is like a practice room for a student to get accustomed to the atmosphere of the Courts as well as improve his skills in law and advocacy law. In a Moot Court, a hypothetical case is given to the students and are allowed to argue the given case. Moot Court helps the students of law in many ways since it is a practical legal training, which helps to build analytical reasoning, legal aptitude, team building skills and above all make them responsive and ready to join practice after completion of their degree course.

## CANTEEN

Our canteen is beautifully design with proper seating arrangement and makes available healthy snacks / meals to the students, and staff member during working hours.

## ANTI - RAGGING CELL

Ragging is strictly prohibited in the college premises and outside. Students indulging in ragging other students will be punished as per "The Maharashtra Prohibition of Ragging Act, 1999" (Mah.XXXIII) published in the Maharashtra Govt. Gazette on 15 May, 1999. Such students will also be expelled from the College and an F.I.R will be lodged with the police against them. Moreover, it will be mentioned in the "College Leaving Certificate" of such students that they are expelled because of their indulgence in ragging. The students found guilty of ragging earlier will not be admitted to this College

#### NOTICE

In pursuance to the Judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009, the University Grants Commission has framed UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009 which have been notified on 4th July, 2009 in the Gazette of India. These regulations are mandatory for all Universities/Institutions. The UGC has made it mandatory for all students / parents to submit anti ragging related affidavits to the institutions at the time of admission. Now it is brought to the notice of all Universities, Institutions, Students and Parents that these affidavits can be downloaded from the website of UGC and or other related websites.

Further as per revised procedure for Anti Ragging Mechanism vide circular of University Grants Commission no. UGC: D.O. No, F.3-2/2021 (ARC) dated 27-10-2021 & University of Mumbai No. SW/17/of 2021, students are requested to adhere to the guidelines issued by UGC for Anti Ragging Mechanism that are as follows:

1. It is mandatory for each student to submit his / her details on the web sites [www.antiragging.in](http://www.antiragging.in) & [www.amanmovement.org](http://www.amanmovement.org) and read and confirm that he/she & his/her parents/ guardians have read and understood the regulations on curbing the menace of ragging.
- 2 The student will receive an Email with his/ her registration number and a web link. The student will forward the said link to the college. **Please note the Anti-Ragging Helpline no. is 1800 180 5522 .**

## APPEAL TO THE STUDENTS

### 1. DISCIPLINE

- In the college premises, every bonafide student of the college must wear the Identity card.
- students should not loiter in the corridors or in the college premises particularly when classes are in session.
- A students should not Invite any outsider to the college premises, classrooms library, canteen or gymkhana.
- No fund raising activity should be undertaken by any student without prior written permission from the principal.
- Students are warned that they should not Indulge in any form of ragging. Any student found Involved or abating in ragging, will be dealt with as per provisions of Law.
- Students are not permitted to park two wheelers or four wheelers in the college premises Bhadran Nagar area.
- Students should take care of, and not cause any damage to the college property.
- The Principal has the power to determine suitable disciplinary action In case of Indiscipline and improper conduct of the students while in the college.
- Parents/ Guardians /students are requested to read and acquaint themselves with the rules of conduct and discipline. Students must ensure strict compliance with these rules.
- if, for any reason, In the opinion of the principal, the continuance of any student in the college is deemed detrimental to the Interest of the college, the Principal may expel such a student from the college. The decision of the Principal in this regard is final.

### 2. DRESS CODE

- Students are expected to wear decent clothes. Students are strictly prohibited from wearing the following while on the college premises:

For BOYS

- Caps, Hats, Half Pants, shorts, Bermudas, Sleeveless T-Shirts and 3/4<sup>th</sup> Pants, Ripped Jeans, Torn Jeans.

For GIRLS

- Caps, Hats, Half-Pants, shorts, Bermudas, Skin tight dresses, revealing dresses, Short dresses or short skirts, Sleeveless and short tops, Ripped Jeans, Torn Jeans, and pedal pushers. Facial piercing other than earrings and nose ring strictly prohibited.

Any other attire which according to the college authorities is not suitable to the College culture/ environment will not be permitted During Academic events such as moot court, client counselling, debates formal activity (Black & White) is to be observed by all students.

### 3. CELLPHONES

- Use of cell phones in any form in the classrooms and corridors & strictly prohibited. On breach of this discipline, the cell phone holder will be able for a penalty of Rs.500/-for the first offence. In case of a repetition of the offence the cellphone shall be able to be confiscated. Cell phones are strictly not allowed in the examination halls.
- 4. Students are required to take adequate care of their belongings while In the college premises. The Management will not be responsible for any theft/ damage to the belongings.
- 5. No Parking Space will be available in the premises.
